WEB SITE DESIGN & IMPLEMENTATION AGREEMENT

1. AUTHORIZATION

The above-named Client (hereinafter referred to as "Client") is engaging Rock Media as an independent contractor for the specific purpose of designing an Internet Web Site, herein after referred to as "Site", to be published on behalf of the Client on a mutually agreed to hosting site. The Client hereby authorizes Rock Media to access and or create this account, access to Site's domain registration and authorizes the Hosting Service to provide Rock Media with "full access" to the Client's account, and any other programs needed for this Site that are included as part of the Client's service agreement/level.

2. DEVELOPMENT

The Site will be developed using HTML5 & CSS3 compliant code to allow for maximum platform and cross-browser compatibility and user accessibility. Unless otherwise requested, we will not implement any Adobe Flash elements. We represent and warrant that The Site will function properly on the current version of all major desktop internet browsers and mobile HTML5 compliant browsers at the time of Site publication.

3. COPYRIGHTS AND TRADEMARKS

The Client unconditionally guarantees that any elements of text, graphics, photos, designs, trademarks, or other artwork furnished to Rock Media for inclusion in the Site are owned by the Client, or that the Client has permission from the rightful owner to use each of these elements, and will hold harmless, protect, indemnify and defend Rock Media from any liability (including attorney's fees and court costs), including any claim or suit, threatened or actual, arising from the use of such elements furnished by the Client.

4. WEB SITE MAINTENANCE

This agreement allows for on-going, routine web site maintenance and updates to all Site pages for the first twelve months at no charge, including updating links, images and making minor changes to a sentence or paragraph structure. It does not include major page reconstruction, new page designs, new blogs, navigation structure changes, or repairs due to attempted updates by Client. The support period begins upon Project Acceptance by Client. Other work required will be quoted and covered under an amendment to this agreement. An on-going maintenance agreement is available after the initial twelve month term.

5. COMPLETION DATE

Rock Media and the Client must work together to complete the Site in a timely manner. We agree to work expeditiously to complete the Site no later than 30 days after Client has submitted all necessary materials. The site will be published and available for a period of no less than 5 days for testing and validation by Client, prior to final acceptance by The Client.

6. PROJECT DELIVERY

The final Site design will be published to the Client's hosting service (included with this proposal) and registered domain url upon receipt of full payment.

7. ELECTRONIC COMMERCE LAWS

The Client agrees that the Client is solely responsible for complying with any laws, taxes, and tariffs applicable in any way to the Site or any other services contemplated herein, and will hold harmless, protect, and defend Rock Media from any claim, suit, penalty, tax, fine, penalty, or tariff arising from the Client's exercise of Internet electronic commerce and/or any failure to comply with any such laws, taxes, and tariffs.

8. SITE COPYRIGHT

Copyright to the finished web design site produced by Rock Media will be owned by The Client. Transfer of ownership will occur, once final payment under this agreement and any additional charges incurred have been paid. Rights to photos, graphics, source code, work-up files, and computer programs specifically are not transferred to the Client, and remain the property of their respective owners. Rock Media retains the right to display graphics and other Web Design elements as examples of its work in its portfolio. All Sites will contain a link to Rock Media Design Services Web Site.

9. PAYMENT

An initial deposit is required prior to the initiation of any work. Final payment is due upon Project Completion and acceptance by The Client of the Sites design, functionality and intended use. All other payments will follow the Payment Schedule outlined in client proposal. Once final payment and signed acceptance has been received by Rock Media, the Site ownership will be transferred to The Client, including copies of the original source code. This agreement becomes effective only when executed by Rock Media and The Client. All payments will be made in U.S. Dollars.

10. LEGAL NOTICE

Notwithstanding anything to the contrary contained in this contract, neither Rock Media nor any of its employees or agents warrants that the functions contained in the Site will be uninterrupted or error-free. In no event will Bradley Rock and/or Rock Media be liable to the Client or any third party for any damages, including, but not limited to, service interruptions caused by Acts of God, the Hosting Service or any other circumstances beyond our reasonable control, any lost profits, lost savings or other incidental, consequential, punitive, or special damages arising out of the operation of or inability to operate this Site, failure of any service provider, of any telecommunications carrier, of the Internet backbone, of any Internet servers, or your site visitor's computer or Internet software, even if Rock Media has been advised of the possibility of such damages.

11. THIS AGREEMENT

This agreement constitutes the sole agreement between Rock Media and the Client regarding this Site.
